1. The A&N Islands Khadi & Village Industries Board with the assistance of Dr. BR Ambedkar Institute of Technology, Pahargaon has decided to conduct "Open, Competitive Recruitment Examination at Port Blair for filling-up Group — 'C' vacant post of 'Supervisor' in the establishment of A&N Islands Khadi & Village Industries Board as per the details given below, for which, **ONLINE APPLICATIONS** are invited from eligible candidates.

2. DETAILS OF VACANCY

GROUP 'C' POST

- Reservation for OBC applicable to those OBCs as specified in the Notification issued by A&N Administration vide Notification No. 354 dated 16.12.2005 and No. 78 dated 19.04.2006 read with Circular No. 8-3/2003-TW dated 30th March, 2006.
- Reservation for disabled persons (Persons with disability) EWS, Ex- Servicemen, Meritorious Sports Persons etc. shall be applicable as per the Notification/Guidelines/Instructions issued by the Govt./ A & N Administration from time to time.

3. Eligibility Conditions:

- All candidates shall be required to apply Online for the post whether they are registered with the Employment Exchange or otherwise.

4. Age Limit:

5. Educational & Other Qualifications prescribed for the Group 'C' post :-

- a) <u>EDUCATIONAL QUALIFICATION</u>: (As on the last date of receipt of application)
 Must have essential qualification as mentioned in Annexure-I
- b) Visually handicapped (VH) candidates with visual disabilities of forty percent (40%) and above and candidates suffering from Cerebral Palsy can avail the assistance of a SCRIBE in the Examination subject to such requests being made in the application form beforehand. Question Papers and Answer Sheets will not be provided in BRAILLE. No attendant will be allowed with Visually Handicapped (VH)/ Cerebral Palsy candidates inside the examination premises.

Note: Persons with Visual disability of less than forty percent (40%) will not be considered as visually handicapped persons. One eyed candidates and partially blind candidates who are able to read the normal Question Paper set for all the candidates with or without magnifying glass and who wish to write/indicate the answer with the help of Magnifying Glass will be allowed to use the Magnifying Glass in the Examination Hall and will not be entitled to a Scribe. Such candidates will have to bring their own Magnifying Glass to the Examination Hall. Similarly, other persons with less than forty percent (40%) disability will not be considered under the VH/HH/OH/MI category as the case may be.

The Examination will be held in Computer based test mode at the designated centers located at **Port Blair** or any other places according to the availability of candidates.

The questions in computer based test will be in English language only.

NOTE-I: There will be negative marking of 0.25 marks for each wrong answer. Candidates are, therefore, advised to keep this in mind while answering the questions.

NB: The ANI KVIB reserves the right to restrict entry to the examination venue

There shall be a single paper for all the four subjects, having: "Objective Multiple-Choice- type Questions". The Authorities Shall however, have full discretion to fix the minimum qualifying marks in one and all the subjects. The question paper in respect of subjects at Sl No.(i), (ii), (iii) & (iv) above will be set in English languages only.

INDICATIVE SYLLABUS:- FOR CBT EXAMINATION (Graduate level):

- i. General Intelligence & Reasoning: The test will include questions on similarities and differences, space visualization, problem solving, analysis, judgement, decision making, visual memory, discriminating observation, relationship concepts, figure classification, arithmetical number series, non-verbal series etc. The test will also include questions designed to test the candidate's abilities to deal with abstract ideas and symbols and their relationships, arithmetical computations and other analytical functions.
- ii. <u>Numerical Aptitude:</u> Questions will be designed to test the ability of arithmetical computation of whole numbers, decimal and fraction and relationship between numbers. This test will also includes question on problems relating to percentage, ratios and proportions, average estimation, use of table and graphs, mensuration, time and distance, ratio and time etc.
- iii. <u>English Language:</u> Questions in this test will be set to assess the knowledge of English Language, its vocabulary, grammar, sentence structure, synonyms, antonyms etc. There may also be questions based on comprehension of a passage.
- iv. General Awareness: Questions will be designed to test the ability of the candidate's general awareness of the environment around him and its application to the society. Questions will also be designed to test knowledge of current affairs, observations/experience and elementary knowledge of computers. The test will also include questions relating to India and other countries especially, pertaining to History, Culture, Geography, Economics, Science, General Politics and Scientific Research etc.



<u>NOTE:</u> For Visually Handicapped (VH) candidates of 40% and above visual disability and opting for SCRIBE, there will be no component of Map/Graphs/Diagrams / Statistical Data in the General Intelligence & Reasoning/ General Awareness Paper.

8. Verification of documents:-

All the successful candidates short listed after Computer Based Test should get their original certificates/ Testimonials duly verified as are mandatory and submit another self attested copy of all those mandatory certificates /testimonials in person alongwith the printed copy of Online Application to the authorized officers/officials at the prescribed venue on the schedule date & time, failing which, his/her candidature shall be struck off from the relevant panel for all purposes and no further request/correspondence shall be entertained.

9. GENERAL INSTRUCTIONS TO BE COMPLIED WITH BY THE CANDIDATES IN THE EXAMINATION .

- In the question papers, wherever necessary, the Metric systems of weights and measures only will be used.
- Candidates are not permitted to use calculators and other electronic gadgets except as specified in the Notice. They should not, therefore, bring the same inside the Examination Premises/ Venue.
- If any candidate is found to possess mobile phones or any other means of wireless communication in the working (Switch on) or switched off mode, his/her candidature shall be cancelled forthwith.

10. MODE OF SELECTION:

Candidates for lone vacancy will be short listed based on their performance in the Computer Based Examination.

Provided that ST, OBC, MSP, EWS, ESM and PwD candidates, who are selected on their own merit without relaxed standards, will not be adjusted against the reserved share of the vacancies. Such MSP, ESM and PwD candidates will be accommodated against the general/unreserved vacancies as per their position in the overall Merit List.

Success at the examination confers no right of appointment whatsoever unless the Board is satisfied after such enquiry as may be considered necessary that the candidate is suitable in all respects of appointment to the service/post and the decision in this regard shall be final & binding.

11. RESOLUTION OF THE TIE CASES

- 11. To be ineligible for the Examination by not fulfilling the eligibility conditions mentioned in the Notice.
- 12. Candidature can also be cancelled at any stage of the recruitment on any other ground which, the A&NI KVIB considers to be sufficient cause for cancellation of candidature.

14. A&NI KVIB DECISION SHALL BE FINAL AND BINDING

The decision of the A&NI KVIB in all matters relating to eligibility, acceptance or rejection of the applications, penalty for false information, mode of selection, conduct of examination(s) allotment of examination center, selection and allotment of posts/organizations to selected candidates shall be final and binding on the candidates and no enquiry/correspondence shall be entertained in this regard.

15. COURTS JURISDICTION

17. IMPORTANT INSTRUCTIONS FOR THE CANDIDATES

- (i) The ANIKVIB has advertised recruitment for Supervisor Group 'C' posts for which, Graduate in Engineering / Science / Commerce qualification required.
- (ii)The Board will not undertake detailed scrutiny of applications for the eligibility and other aspects before the Computer Based examination, and thus the candidature is accepted only provisionally. The candidates are advised to go through the requirements of educational qualification, age etc. and satisfy themselves that they are eligible before applying. When scrutiny is undertaken, at any stage, if any claim made in the application is not found substantiated, the candidature shall be cancelled and the Board's decision shall be final and binding.



- (iii) Candidates are advised to go through the detailed instructions contained in this notice which are available on the websites of A&N Administration i.e.
